

**AN ORDINANCE ESTABLISHING THE HOUR FOR
THE MAYOR AND BOARD OF ALDERMEN OF THE
CITY OF CANTON, MISSISSIPPI, TO HOLD REGULAR MEETINGS**

WHEREAS, the Mayor and Board of Aldermen of the City of Canton, Mississippi, previously adopted an Ordinance fixing the hour of its regular meetings at 6:00 o'clock p.m. on the first and third Tuesdays of each month; and,

WHEREAS, the Mayor and Board of Aldermen have determined that it is in the best interest of the City of Canton and its citizens to change said meeting time to 4:00 o'clock p.m. on the first and third Tuesdays of each month; and,

WHEREAS, that this Ordinance shall become effective thirty (30) days from and after passage with the first meeting to be held pursuant to this Ordinance on Tuesday, the 4th day of January, 2011 at 4:00 o'clock p.m.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CANTON, MISSISSIPPI, that the Mayor and Board of Aldermen of the City of Canton, Mississippi, shall conduct regular meetings on the first and third Tuesdays of each month commencing at 4:00 o'clock p.m. in the Canton City Hall located at 226 East Peace Street, Canton, Mississippi.

BE IT, FURTHER, ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CANTON, MISSISSIPPI, this Ordinance shall become effective thirty (30) days from and after passage, and the first meeting to be held pursuant to this Ordinance shall be on Tuesday, the 4th day of January, 2011, at 4:00 o'clock p.m.

BE IT, FURTHER, ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CANTON, MISSISSIPPI, that any ordinances or parts of ordinances heretofore adopted by the Mayor and Board of Aldermen in conflict with the Ordinance be and same are hereby repealed.

SO ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF CANTON, MISSISSIPPI, this the 16th day of November, 2010.

Said Ordinance being first reduced to writing and after discussion on the matter, full and complete, Alderwoman Alice Scott moved for the adoption of the above and foregoing Ordinance. Alderman Charles Weems seconded the motion to adopt said Ordinance and the question being put to a roll call, the result was as follows, to wit:
